How to Enroll:

- Simply fill in the form and return it to American Express. This form will authorize your nominated Bank to debit your bank account for the amount due on your Credit Card Account.
- If you have previously applied for the Direct Debit Service on your American Express Charge Card or Credit Cards and now wish to apply for the Direct Debit Service on your Credit Card, please complete this application form again.
- 3. We will immediately notify your nominated Bank, which will confirm your participation in the Direct Debit system. Please continue to pay your bill by cash or cheque by the date specified on your monthly statement until you see the Direct Debit message on your statement.

How the Service Works:

- 1. We will send you your monthly statement just as before. All you have to do is check your monthly statement and make sure you have sufficient funds in your bank account to cover your expenditure. The statement will specify the date your bank account will be debited, which is approximately 25 days from date of statement.
- The Bank will usually deduct the payment from your bank account before the beginning of its working hours. If you need to make additional deposits to your bank account to cover the full payment, please allow clearing time before the direct debit date;
 - For cash deposits: 1 day
 - · For Bangkok cheques: 3 days
 - For upcountry cheques: please check with your bank
 - For any other deposits: please check with your bank
