### EXAMPLE BASED ON LEVEL 1 MEMBERSHIP\*

SYD-MEL Economy = 1,200 Qantas Points

20% of 1,200 = 240 Qantas Points

240 Qantas Points x 3 = 720 Qantas Points

1. Individual's Qantas Frequent Flyer Number must be entered into booking to earn Qantas Points.

2. Individual's Qantas Frequent Flyer Number and ABN must be entered into booking to earn Qantas Points for the business.

\*Your business will move up to the next level automatically once you have earned the required amount of points from flights. Examples used are for illustration purposes only. <sup>^</sup>Qantas Frequent Flyers will earn 250 Qantas Points per eligible flight booking where a Qantas Business Rewards Member's ABN and the traveller's Qantas Frequent Flyer membership number are quoted at the time of booking. A business must be a Qantas Business Rewards Member to earn triple Qantas Points for business.

#### Terms & Conditions

A business must be a Qantas Business Rewards Program member to earn Qantas Points for business. The TRIPLE Qantas Points for business benefit is available only for companies with the American Express Qantas Corporate Card program when the Card is used to make an eligible Qantas flight booking. An eligible flight means a domestic or international flight which has a Qantas 'QF' flight number on the ticket that is purchased in Australia; is operated by Qantas, Emirates or American Airlines; has a ticket number commencing with '081'; and is booked and travelled for business on or after the date the business registers for Qantas Business Rewards. Exclusions apply. Qantas will allocate 3 times the number of Qantas Points which will be awarded to the business under the Qantas Business Rewards Airline Reward Scheme Terms and Conditions. A one-off joining fee of \$89.50 usually applies, however this will be waived for any business that has an existing American Express Qantas Corporate Card. Qantas Points earned on air travel are determined in accordance with the airline earn table. A Member's ABN and traveller's Qantas Frequent Flyer membership number must be quoted at the time of booking to earn Qantas Points for both the business and the traveller. Qantas Points earning thresholds apply as per the TRIPLE Qantas Points for business benefit Terms and Conditions. Membership of Qantas Business Rewards and the earning of Qantas Points as a business are subject to the Qantas Business Rewards Terms and Conditions.
