

AU\$1 MILLION AMERICAN EXPRESS MUSIC BACKERS FUND NOMINATE A MATE COMPETITION

CONDITIONS OF ENTRY

- Information on how to enter and prizes form part of these Conditions of Entry. Registration and entry in this promotion is deemed acceptance of these Conditions of Entry.
- The Promoter (the "Promoter" or "American Express") in Australia is American Express Australia Limited (ABN 92 108 952 085) of 12 Shelley Street, Sydney NSW 2000.
- 3. The **Promotion Period** commences at 10:00AM AEST Monday 3 August 2020 and closes at 11:59PM AEST on Sunday 13 September 2020. Entries received outside the Promotion Period will not be accepted.

ELIGIBILITY

- 4. **Eligible Entrants** include both the **Eligible Nominee** and the **Eligible Nominator**. Eligible Entrants do not need to be American Express Card Members.
- 5. Eligible Entrants must be:
 - (a) Over the age of 18 years; and
 - (b) An Australian Citizen or Permanent Resident. Eligible Entrants living outside of Australia must be planning to return to Australia within the next twelve months.
- 6. Employees of American Express and any related bodies corporate, any other agencies associated with this promotion, and their immediate families, are ineligible to enter.
- 7. Charities, groups, businesses and government organisations are not eligible to receive the prize. The promotion is open to eligible individuals only.

NOMINEE PRIZE: PRIZE DETAILS

Nominee Total Prize Value

9. The Total Prize Pool for the Nominee Prize is AU\$150,000.

Details of the Nominee Prize:

 - (a) Each Eligible Nominee will be awarded a AU\$1,500 cash prize.
- 11. Nominee Prize conditions:
 - (a) The promotion for the Eligible Nominee is a Game of Skill. Chance plays no part in determining the winners. The top entries that best fit the judging criteria, as selected by the judges, will receive the prize outlined above. American Express reserves the right to confirm the validity of any entry.
 - (b) Eligible Entrants are unable to win in both the Nominee and Nominator Prize Pools in the event that an Eligible Entrant is awarded the Nominee Prize, they automatically forfeit any right to entry or winning of the Nominator Prize.

NOMINEE PRIZE: JUDGING AND WINNER NOTIFICATION

- 12. The judging for the Nominee Prize will take place as follows:
 - (a) Nominee Prizes will be judged and awarded at two points during the Promotion Period.
 - I. The judging of the first round of Nominee Prize Winners will take place between Monday 24 August 2020 and Friday 28 August 2020.
 - II. The judging of the second round of Nominee Prize Winners will take place between Monday 14 September 2020 and Friday 18 September 2020.
 - III. Eligible Entrants who are not awarded a Nominee Prize in the first round will be eligible for and automatically entered into the second round of judging.
 - (b) Winners of the Nominee Prize will be notified by phone and in writing via email within 7 business days of the end of the judging period. Nominee Prize Winners must claim their prize by confirming acceptance via return email of the Promoter's notification of winning.

NOMINATOR PRIZE: PRIZE DETAILS

Nominator Total Prize Value:

- 15. There are 20 Nominator Prizes to be awarded. The Total Value of each individual prize is AU\$250, supplied to the Eligible Nominator in the form of an e-Gift Card for Ticketmaster.
- 16. The Total Prize Pool for the Nominator Prize is valued at AU\$5,000, supplied in e-Gift Cards.

- I. Ticketmaster e-Gift Cards can be used to buy eligible tickets and associated products for events in Australia, online at <u>www.ticketmaster.com.au</u>
- II. Ticketmaster e-Gift Cards are activated at the time of purchase by the Promoter and expire 3 years after activation. Once the e-Gift Card has expired any remaining balance will no longer be available to use.
- (c) American Express takes no responsibility for lost, stolen, misplaced or expired Gift Cards, and no monetary compensation will be awarded in this event.
- (d) The balance of the e-Gift card can be checked online via Ticketmaster's <u>balance</u> <u>checker</u>.
- 18. Nominator Prize conditions:

NOMINATE A MATE: HOW TO ENTER

24. To enter the competition, Eligible Nominators must, during the Promotion Period:

- (c) Follow the prompts to complete their entry including providing:
 - The Eligible Nominator's full name, phone number, email address and location
 - The Eligible Nominee's full name, phone number, email address and location
 - No more than 300 words detailing the way in which the Eligible Nominee has inspired the Eligible Nominator through positive impact on others, contribution to the music industry or resilience in the face of hardship.
- (d) Seek the permission of the Eligible Nominee to share their story and supply their full name, location, email address and phone number for the purpose of this Promotion.
- 25. An eligible Nominator can submit up to five (5) entries, each for a different Eligible Nominee. Each entry must contain a maximum of 1 (one) Eligible Nominee. There is no limit as to how many times an Eligible Nominee can be nominated, provided that each nomination is completed by a different Eligible Nominator. An Eligible Nominator may not nominate themselves.

GENERAL CONDITIONS

- 27. No compensation will be awarded in lieu of the prize.

- 29. The Promoter reserves the right to request winners of both prizes to provide proof of identity, proof of residency at the nominated prize delivery address and/or proof of entry validity. - 32. Unless expressly stated in these Conditions of Entry any expenses related to the Nominator Prize or Nominee Prize are the responsibility of the winner.
- 33. If the Nominee Prize or Nominator Prize are unavailable, for whatever reason, the Promoter reserves the right to substitute the prize for a prize of equal or greater value, subject to any written regulatory direction or as required by law.
- 34. It is a condition of accepting the Nominator Prize or the Nominee Prize that the winner may be required to sign a legal release in a form determined by the Promoter in its absolute discretion.
- 35. The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these conditions or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. The Promoter's legal rights to recover damages or other compensation from such an offender are reserved.

The Promoter and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission; communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.

- 44. If for any reason this competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, pandemic, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the competition, subject to any written regulatory direction or as required by law.
