

## TERMS AND CONDITIONS

1. The registration period commences on November 19, 2021 and ends on February 28, 2022, both dates inclusive ("Promotion Period").
2. Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend a cumulative net amount of every HK\$300, ("Spending Requirement") in-person at [participating Choi Fung Hong locations](#) in Hong Kong ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$50 back in statement credit ("Registered Card Offer").
3. The Registered Card offer is open to individuals who hold basic and/or supplementary American Express® Cards issued in Hong Kong by American Express International, Inc. and American Express Cards issued by DBS Bank (Hong Kong) Limited ("Eligible Cards"), excluding American Express Corporate Cards.
4. During the Promotion Period, the Registered Card offer is limited to 3-time credits, [up to a total of HK\$150 statement credit] per Registered Card.
5. Participation is limited to the first 2,000 Eligible Cards that are successfully registered.
6. Excludes transactions where Cardmembers do not spend on their registered card directly in person [at participating Choi Fung Hong](#). Offer valid at Hong Kong locations only. Excludes transactions made online.
7. Supplementary Cards must be registered separately and spend cannot be combined amongst Cards to meet the Spending Requirement.
8. Excludes transactions made through a third-party establishment or third-party payment processor.
9. Un-posted/cancelled/refunded transactions and transactions that are found to be fraudulent or are eventually cancelled/refunded will be considered as ineligible transactions.
10. Credit is not redeemable for cash or other payment form.
11. Credit should appear on Cardmember's billing statement within 5 business days from Eligible Transaction but may take up to 100 business days from the end of Promotion Period.
12. Credit may not be applied to the Cardmember's Account if the account has been suspended or cancelled and may be reversed if Eligible Transaction is returned or cancelled.
13. Participating Merchants is solely responsible for all products, services, consultations and advice. American Express International, Inc. ("American Express") is not the provider of any of these products and/or services that are made available pursuant to the Registered Card Offer and makes no representation or warranty in relation to such products and/or services.
14. In the event of any dispute arising from this promotion, the decision of American Express and Participating Merchants shall be final.
15. In the event of any inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

## 條款及細則

1. 此登記卡優惠適用於 2021 年 11 月 19 日至 2022 年 2 月 28 日，包括首尾兩天（「推廣期」）。
2. 會員須於推廣期內成功登記合資格美國運通卡，並在推廣期內憑已登記卡親身於香港[彩豐行（「參與商戶」）](#)[參與門市](#)累積簽賬淨額每滿 HK\$300（「簽賬要求」）（「合資格交易」），可獲 HK\$50 簽賬回贈（「登記卡優惠」）。
3. 此優惠適用於美國運通國際股份有限公司（「美國運通」）及星展銀行(香港)有限公司在香港簽發的美國運通主卡及 / 或附屬卡（「合資格美國運通卡」）。美國運通公司卡不適用於此登記卡優惠。
