

TERMS AND CONDITIONS

1. The registration period commences on November 19, 2021 and ends on December 20, 2021, both dates inclusive ("Promotion Period").
2. Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend a cumulative net amount of every HK\$800 ("Spending Requirement") online at godiva.com.hk or in-store at Godiva locations ("Participating Merchants") with the Registered card during Promotion Period ("Eligible Transaction") to receive a HK\$120 back in statement credit ("Registered Card Offer").
3. During the promotion period, the Registered Card offer is limited to 5-time credits, [up to a total of HK\$600 statement credit] per Registered Card.
4. The Registered Card offer is open to individuals who hold basic and/or supplementary American Express® Cards issued in Hong Kong by American Express International, Inc. and American Express Cards issued by DBS Bank (Hong Kong) Limited ("Eligible Cards"), excluding American Express Corporate Cards.
5. Participation is limited to the first 5,000 Eligible Cards that are successfully registered.
6. Purchases made through phone or at locations within department stores (Godiva SOGO) are excluded from the Registered Card Offer.
7. Supplementary Cards must be registered separately and spend cannot be combined amongst Cards to meet the Spending Requirement.
8. Excludes transactions where Cardmembers do not spend on their registered card directly online at godiva.com.hk or in-store at Godiva. Offer valid at Hong Kong locations and website only.

10. Un-posted/cancelled/refunded transactions and transactions that are found to be fraudulent or are eventually cancelled/refunded will be considered as ineligible transactions.

12. Credit should appear on Cardmember's billing statement within 5 business days from Eligible Transaction but may take up to 100 business days from the end of Promotion Period.
13. Credit may not be applied to the Cardmember's Account if the account has been suspended or cancelled and may be reversed if Eligible Transaction is returned or cancelled.
14. Participating Merchants is solely responsible for all products, services, consultations and advice. American Express International, Inc. ("American Express") is not the provider of any of these products and/or services that are made available pursuant to the Registered Offer and makes no representation or warranty in relation to such products and/or services.
15. In the event of any dispute arising from this promotion, the decision of American Express and Participating Merchants shall be final.
16. In the event of any inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

條款及細則

1. 此登記卡優惠適用於 2021 年 11 月 19 日至 2021 年 12 月 20 日，包括首尾兩天（「推廣期」）。
2. 會員須於推廣期內成功登記合資格美國運通卡，並在推廣期內憑已登記卡親身於香港 Godiva 門市或其網上商店 godiva.com.hk（「參與商戶」）累積簽賬淨額每滿 HK\$800（「簽賬要求」）（「合資格交易」），每次可獲 HK\$120 簽賬回贈（「登記卡優惠」）。
3. 在推廣期內，每張已登記之美國運通卡只可享有最多五次登記卡優惠，即總共 HK\$600 簽賬回贈。
