



### CPA Australia American Express® Gold Credit Card Terms and Conditions

1. This Terms and Conditions are only valid for approved CPA Australia American Express Gold Credit Card applications that are submitted via designated website with RSVP code and are successfully approved by American Express International, Inc. ("American Express") on or before December 31, 2025.
2. In case of any enquiry related to this Terms and Conditions, please call the 24-hour enquiry hotline shown at the back of your card or American Express Customer Service hotline at 2277 1010.
3. Basic Cardmember will be automatically enrolled into the American Express Membership Rewards® **Turbo** Program, and the annual fee of HK\$240 in the **Turbo** will be waived as long as Basic Cardmember hold a valid CPA Australia American Express Gold Credit Card which remains in good standing and is not cancelled for any reason.
4. A spending cap applies to the Membership Rewards **Turbo** Program.
