

CPA Australia American Express® Platinum Credit Card Welcome Offers Terms and Conditions

- 1. The Welcome Offers (as mentioned in clauses 3 to 5 of the Terms and Conditions) are only valid for approved CPA Australia American Express Platinum Credit Card applications that are submitted via designated website with RSVP code and are successfully approved by American Express International, Inc. ("American Express") on or before December 31, 2025.

- 3.
