

Terms and Conditions of Hong Kong Flights Booking Offer:

1. The following Offer ("Offer") is valid for bookings made from March 12, 2026 00:01 HKT to April 12, 2026 23:59 HKT ("Booking Period"). Travel periods for flights are from March 12 to August 31, 2026 HKT, both dates inclusive ("Travel Period").

Offer: Enter the promo code **HXAMEX26** to enjoy HK\$500 savings on the net ticket price for one-way or round-trip flights departing from Hong Kong, applicable to ticket prices of HK\$5,000 or above.

From March 13, 2026, the net fare (excludes the surcharges and taxes) of each air ticket should be HK\$3,000 or above and spend a net amount of HK\$5,000 in a single transaction to enjoy the offer.

2. All payments must be settled in full with American Express® Cards issued in Hong Kong by American Express International, Inc. ("American Express") ("Eligible Cards", such holders, "Eligible Cardmembers"), unless otherwise specified below, in order to enjoy the Offer.
