



西九文化區門市餐飲優惠條款及細則

1. 此登記卡優惠（「優惠」）適用於 2024 年 11 月 1 日至 30 日，包括首尾兩日（「推廣期」）。此登記卡優惠只適用於首 30,000 張成功登記此優惠之合資格美國運通卡。
