

## Registered Card Offer Terms and Conditions

- 1. The Registered Card Offer (as define in clause 3 of these Terms and Conditions) commences on July 1, 2021 and ends on September 30, 2021, both dates inclusive ("Promotion Period").
- 2. Only selected Basic Cardmembers of American Express Explorer™ Credit Card issued in Hong Kong by American Express International, Inc. ("American Express") who receive this email and specified in this email ("Eligible Card" and such holders, "Eligible Cardmembers") are eligible to participate in the Registered Card Offer. All other American Express® Cards, Corporate Cards issued by American Express and American Express Cards issued by DBS Bank (Hong Kong) Limited are not eligible to participate in the Registered Card Offer.
- 3. Eligible Cardmembers will accrue 3 Membership Rewards® points for every HK\$1 spent on eligible local transactions with an Eligible Card from the basic points earned under the American Express Membership Rewards Program. Eligible Cardmembers must successfully register an Eligible Card and spend with the Registered Card during the Promotion Period, in order to earn an additional 2 Membership Rewards points for every HK\$1 spent on eligible local transactions by contactless payment or via Apple Pay, Google Pay or Samsung Pay from this Registered Card Offer ("Registered Card Offer").
- 4. Transactions must be made via contactless payment, Apple Pay, Google Pay or Samsung Pay ("Spending Requirement") to be considered as Eligible Transactions. Eligible Cardmembers must either be tapping or holding your Registered Card close to a contactless enabled terminal for payment or load the Registered Card, using a compatible device, to any of the Mobile Wallets below to make an Eligible Transaction and it is subject to the relevant Mobile Wallets Terms and Conditions under the "Important Information from American Express":
  - Apple Pay
  - Google Pay
  - Samsung Pay
- 5. During the Promotion Period, the Registered Card Offer is limited to first HK\$10,000 eligible local transactions per Registered Card. Unused Registered Card Offer will be forfeited.
- 6. Supplementary Cards are not eligible for this Registered Card Offer.
- 7. Un-posted/cancelled/refunded transactions and transactions that are found to be fraudulent or are eventually cancelled/refunded are not considered as Eligible Transactions.
- 8. Excludes transactions where Eligible Cardmembers do not spend on their Registered Card directly using contactless payment and Apple Pay, Google Pay or Samsung Pay (E.g. by swiping or inserting a physical Card).
- 9. Membership Rewards points are not redeemable for cash or other payment form.
- 10. Membership Rewards points should appear on Eligible Cardmember's billing statement within 5 business days from Eligible Transaction(s) but may take up to 100 business days from the end of Promotion Period.
- 11. Membership Rewards points may not be applied to the Cardmember's Account if the account has been suspended or cancelled and may be reversed if Eligible Transaction(s) is/are returned or cancelled.

## 登記卡優惠條款及細則

- 1. 登記卡優惠(在本條款及細則第3條定義)由 2021年7月1日開始至2021年9月30日結束·包括首尾兩日(「推廣期」)。
- 2. 登記卡優惠只適用於持有美國運通國際股份有限公司(「美國運通」)於香港簽發的美國運通 Explorer™信用卡基本卡以及獲發此推廣電郵之會員(「合資格卡」)・其持卡人為(「合資格會員」)。其他美國運通卡、美國運通公司卡、星展銀行(香港)有限公司在香港簽發的美國運通卡並不適用於此登記卡優惠。
- 3. 合資格會員憑合資格卡作本地簽賬每 HK\$1 可於美國運通積分計劃所獲享之基本積分內獲 3 美國運通積分。 合資格會員必須於推廣期內登記合資格卡·並憑已登記卡以非接觸式方式付款或透過 Apple Pay、Google Pay 或 Samsung Pay 作合資格本地消費·使用登記卡優惠每 HK\$1 之簽賬可獲額外 2 美國運通積分 (「登記卡優惠」)。
