



## American Express® Gold Business Card

### Welcome Offer Terms and Conditions:

1. The Welcome Offer (as mentioned in clauses 4 to 8 of the Terms and Conditions) is only valid for American Express Gold Business Card applications that are received and approved by American Express International, Inc. Transactions made via a third-party (including, but not limited to, authorized retailers or resellers, online marketplaces, online aggregators or electronic wallets) are not eligible for the Business Essential Merchant Bonus.

Thereafter, annual Card fee of **HK\$980** of the following year (include 1 basic Card and 3 supplementary Cards) will be charged at the time of annual Card fee renewal. Existing American Express Business Card or Gold Business Cardmembers and applicants who held the Basic Card of American Express Business Card or Gold Business Card at any time within the past 12 months from the date of this application are not eligible for the first-year annual fee waiver and the Welcome Offer. American Express reserves the right to debit the original price of the Welcome Offer and first-year annual fee without prior notice.
