



Terms and Conditions:

1. A one-time registration is required for the Eligible Card which will be automatically registered for the following calendar month from the registration date and do not need to re-register.
2. The Registered Card Offer resets on the 1st day of next calendar month 2024/08/01.
3. Spending Requirement will reset each calendar month, transactions must be charged to the Cardmember's Registered Card and must meet the Spending Requirement of HK\$40,000 prior to the end of each calendar month (end of month in July 2 - 31 and August 1 - 31) to be eligible for the HK\$1,200 statement credit within that calendar month.
4. The registration period commences on 2024/07/02 and ends on 2024/08/31, both dates inclusive ("Promotion Period").
5. Cardmembers must successfully register an Eligible Card during the Promotion Period ("Registered Card"), then spend a cumulative net amount of HK\$40,000 or more per calendar month ("Spending Requirement") in-person, online or in-app at any American Express Card accepting merchants ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$1,200 back in statement credit per calendar month ("Registered Card Offer").
6. The Registered Card Offer is open to selected Basic American Express Explorer® Credit Cards issued by American Express International, Inc. ("American Express") in Hong Kong ("Eligible Cards").
