### **Marriott Bonvoy® Terms and Conditions**

- A minimum of 100 Membership Reward Points must be transferred in a single redemption transaction.
- A maximum of 900,000 Points can be transferred per redemption transaction.

- Membership Rewards points transfers must be made in multiples of 100 points. The Membership Rewards Points transfer ratio is 100 MR Points = 100 Marriott Bonvoy Points
