



Terms & Conditions for The American Express® Singapore Airlines Business Credit Card Singapore Airlines Exclusive Sign Up Promotion – Up to 38,000 HighFlyer points

Promotion

1. The American Express Singapore Airlines Business Credit Card Singapore Airlines Exclusive Sign Up Promotion (the “Promotion”) is valid from 30 October 2025 to 29 December 2025, both dates inclusive (the “Promotion Period”).
2. To be eligible for this Promotion, you must satisfy all the following criteria:
  - 2.1 You must apply for The American Express Singapore Airlines Business Credit Card within the Promotion Period and receive approval by 29 December 2025 (date inclusive).
  - 2.2 You must pay the full Annual Fee of S\$400.00 (incl. of 9% GST) in the first monthly statement

  - 2.4 You must not have previously cancelled The American Express Singapore Airlines Business Credit Card for the same company in the last twenty-four (24) months prior to the application.
  - 2.5 You must not have already submitted an application for a Basic American Express Singapore Airlines Business Credit Card under other promotion(s).

Mechanics

3. If you fulfil the following Criteria, which includes spending S\$1,000 on eligible purchases of goods and services (“Qualifying Spend”) within the first two (2) months upon Card approval (“Qualifying Spend Period”), you will receive the Gift (as indicated in the table below).
