



# Public Country-by-Country Report (EU Public Country-by-Country Report)

Financial Year 2025 (from 1 January 2025 to 31 December 2025)

Pursuant to paragraph One.1.4 of the Eleventh Additional Provision of Law 22/2015 of 20 July on Audit of Accounts (the "Audit Law"), as amended by Law 28/2022 of 21 December, which transposed into Spanish law the public country-by-country reporting requirements introduced by Directive (EU) 2021/2101 of the European Parliament and of the Council of 24 November 2021 amending Directive 2013/34/EU as regards the disclosure of income tax information by certain undertakings and branches, **American Express Europe, S.A., American Express Payments Europe, S.L., American Express de España, S.A.U. and Amex Asesores de Seguros, Sociedad de Agencia de Seguros Vinculada, S.A.U.** (together, the "Spanish American Express Entities"), subsidiaries of the American Express Group, are required to publish and make accessible a report on income taxes or taxes of an identical or similar nature at the consolidated level of their ultimate parent undertaking for the financial year 2025.

This obligation applies because:

- The Spanish American Express Entities are entities governed by Spanish law.
- American Express Company, a corporation incorporated and tax resident in the United States of America, is the ultimate parent undertaking of the American Express Group and is not governed by the law of a Member State of the European Union.
- American Express Company is the parent undertaking of a multinational group whose consolidated net turnover exceeded the threshold of EUR 750 million in each of the two preceding consecutive financial years, as required under the applicable public country-by-country reporting legislation.

In compliance with the obligations established by the Audit Law, the Spanish American Express Entities hereby publish this Report on Income Taxes for the financial year 2025.

The publication of this report reflects American Express's commitment to tax transparency and to compliance with the disclosure obligations established under European Union and Spanish legislation.

This report has been prepared in accordance with the requirements of the Eleventh Additional Provision of the Audit Law and contains the information required regarding the geographical allocation of certain economic, tax and employment data of the American Express Group. In particular, it includes information relating to revenues, profit or loss before income tax, income taxes paid and accrued, accumulated earnings and number of employees, in accordance with the criteria established by the applicable legislation.

It should be noted that the information contained in this report has been prepared for the specific purposes of public country-by-country reporting and is therefore based on definitions, aggregation methodologies and presentation principles that differ from those applicable to the Group's consolidated financial statements. Accordingly, the information contained in this report should not be considered in isolation or used as a basis for assessing the financial position, operating performance or overall tax contribution of the American Express Group in any particular jurisdiction.

This report has been prepared based on financial information following the United States' Generally Accepted Accounting Principles (U.S. "GAAP").
