



## 美國運通 x 百老匯院線優惠 - 條款及細則

( 修訂版：條款 6 已作修訂，並以橫底線作識別。上述修訂於 2025 年 6 月 23 日生效。 )

1. 美國運通 x 百老匯院線優惠只適用於持有由美國運通國際股份有限公司（「美國運通」）於香港簽發的基本卡及附屬卡（「合資格卡」）之卡會員（「合資格卡會員」）。不適用於美國運通公司卡、並非於香港簽發的美國運通卡以及由美國運通特許發卡公司於香港簽發印有美國運通公司名稱、品牌或商標的運通卡。
2. 優惠（於條款細則 3 內所定義）適用於 2025 年 1 月 1 日至 2025 年 12 月 31 日，包括首尾兩天（「優惠期」）。
3. 優惠期內，合資格卡會員於百老匯院線、GALA CINEMA、Premiere Cinemas、PALACE、MOVIE MOVIE, B+ cinema 及 My Cinema（「參與商戶」）以合資格卡全數簽賬（「合資格簽賬」），可享以下指定優惠（以下統稱「優惠」）：

優惠三	逢星期五 3D、2D 及 IMAX 電影正價戲票買一送一	適用於由美國運通於香港簽發的 Centurion 卡、美國運通白金卡、美國運通白金信用卡、美國運通 Charter 卡之基本卡及附屬卡。

4. 優惠只適用於每張合資格卡每日最多 8 張戲票之交易，包括優惠三買一送一優惠所贈送的戲票（即是於優惠三購買 4 張或以上指定正價戲票，每張合資格卡每日可獲贈最多 4 張戲票）。
5. 優惠只適用於在百老匯院線的售票處或經其網站購買之戲票。

- iv. 所有星期二上映之電影、「早場」及「中午場」上映之電影（有關「早場」及「中午場」之詳情，請向參與戲院查詢）；及
- v. 與電影發行商有特別協議之電影。

合資格卡會員可於預訂前與有關戲院查詢優惠之有效性。

- 7. 優惠一及優惠三不適用於 VIP HOUSE、4DX 電影及電影節。
- 8. 優惠二不適用於 VIP HOUSE 及電影節。
- 9. 優惠三只適用於逢星期五上午 8 時至星期六凌晨 4 時之電影，及同一場次之電影。
- 10. 所有優惠不可同時使用，亦不可與其他優惠同時使用。
- 11. 透過百老匯院線網站購票，Cinema.com.hk Ltd. 將會收取手續費。優惠不適用於手續費，並需由合資格卡會員承擔支付。
