



Terms and Conditions of Cathay Pacific Flights Booking Offer:

1. Cathay Pacific Flights Booking Offer ("Offer") is valid for bookings made from October 13, 2025, 10:00 a.m. to November 12, 2025, 11:59 p.m. (Hong Kong time) (both dates inclusive) ("Promotion Period"). The departure dates of the Eligible Bookings (as defined below) must be during the period from October 13, 2025 to February 8, 2026 (both dates inclusive).
2. All payments must be settled in full with American Express® Cards issued in Hong Kong by American Express ("Eligible American Express Cards", such holders, "Eligible Cardmembers"), unless otherwise specified below, in order to enjoy the Offer. American Express Cardmembers settling with the American Express® Corporate Cards, US Dollar Card, American Express Business Travel Account or Corporate Purchasing Card are not eligible to enjoy the Offer. Cards bearing the American Express name, brand or logo issued by partners of American Express and all American Express Cards issued outside of Hong Kong are not eligible to enjoy the Offer.

Any request to apply the discount code after checkout will not be accepted.

The discount code is eligible for using on Cathay Pacific marketed and operated round-trip Business class or Premium Economy class flight tickets, applicable for flights departing from Hong Kong to selected destinations only, which are set out on the promotion webpage here: https://flights.cathaypacific.com/en_HK/offers/amex-offer-2025.html
6. The Offer is available for bookings with at least two (2) or more adult passengers travelling together for the entire journey.
7. The discount code may not be used on flight tickets that are open-jaw, stopover, multi-city, package or booked on the Cathay Pacific mobile app and other channels.
