



美國運通 x city'super 原箱日本水蜜桃預訂優惠 (2025 年 7 月份) — 條款及細則

1. 美國運通 x city'super 原箱日本水蜜桃預訂優惠適用於由美國運通國際股份有限公司（「美國運通」）於香港簽發之美國運通卡（「合資格卡」，其卡會員為「合資格卡會員」）之基本卡及附屬卡會員。優惠不適用於美國運通美元卡、美國運通公司卡、美國運通商務旅遊賬戶或美國運通公司採購卡之卡會員。由美國運通特許發卡公司於香港簽發印有美國運通公司名稱、品牌或商標的運通卡，即星展銀行（香港）有限公司所簽發的美國運通卡及在香港以外地區簽發的美國運通卡簽賬，均不可享此優惠。
