



Terms and Conditions:

1. The registration period commences on November 22, 2022 and ends on December 22, 2022, both dates inclusive ("Promotion Period").

條款及細則：

1. 登記期由 2022 年 11 月 22 日開始至 2022 年 12 月 22 日結束，包括首尾兩日（「推廣期」）。
2. 會員須於推廣期內成功登記合資格卡，並在推廣期內憑已登記的合資格卡親臨位於香港 APITA、UNY 或谷辰（「參與商戶」）門市單一簽賬淨額滿 HK\$600 或以上（「簽賬要求」）的交易（「合資格交易」），方可享 HK\$50 簽賬回贈（「已登記卡優惠」）。
