

MERCHANT OFFER TERMS AND CONDITIONS – HILTON

- 1. The Registered Card Offer commences 02/05/2019 and ends 30/09/2019, both dates inclusive ("Promotion Period").
- Eligible Cardmembers must successfully register an Eligible Card during the Promotion Period, then spend HK\$1,500 or more on the registered Card ("Spending Requirement"), in one or more transactions at <u>participating Hilton Portfolio of Hotels & Resorts</u> during the Promotion Period ("Eligible Transaction") to receive a statement credit of HK\$400, up to a maximum of three credits ("Registered Card Offer").
- 3. Participating Hilton Portfolio of Hotels & Resorts properties are located in Australia, Mainland China (Beijing, Guangzhou, Sanya, Shanghai, Shenzhen), Hong Kong, India, Japan, New Zealand, Singapore & Thailand.
- 4. Eligible Transactions must be made during the Promotion Period online at the <u>Hilton website</u> or <u>Hilton Honors website</u>, via phone to <u>Hilton Reservations & Customer Care</u>, via the <u>Hilton Honors mobile app</u> or directly in-person at the front desk of <u>participating Hilton Portfolio of Hotels & Resorts</u>. Excludes gift cards purchased online.
- 5. Transactions made via third parties (including, but not limited to, travel agents, online aggregators or payment processors) are ineligible for the Registered Card Offer.
- 6. Incidental spend is eligible if charged to the Eligible Cardmember's room during their stay and paid at the hotel front desk upon check-out (e.g. spend at hotel restaurants).
- 7. Payments for stays at locations outside Hong Kong are charged in the property's local currency and will be converted to Hong Kong Dollars based on the rate of exchange at the time the Card is charged. Eligible Cardmembers must meet the Spending Requirement after currency conversion to be eligible for the Registered Card Offer.
- 8. Participation is limited to the first 8,000 American Express® Cards that are successfully registered.

Cardmember's holding ("Eligible Cardmember") American Express® Platinum Credit Card, Blue Cash™ Credit Card from American Express, American Express® I.T Cashback Card, American Express® Cathay Pacific Elite Credit Card, American Express® Cathay Pacific Credit Card, American Express® Business Card, American Express® Gold Business Card, issued in Hong Kong by American Express International, Inc. - 13. Credit should appear on Cardmember's billing statement within 5 business days from an Eligible Transaction but may take up to 100 business days from the end of the Promotion Period.

- 14. Credit may not be applied to the Cardmember's Account if the account has been suspended or cancelled and may be reversed if Eligible Transaction is returned or cancelled.

優惠之條款及細則-希爾頓酒店

- 1. 此登記卡優惠適用於2019年5月2日至2019年9月30日,包括首尾兩天(「推廣期」)。
- 2. 合資格會員須於推廣期內成功登記合資格美國運通卡,在推廣期內於希爾頓旗下品牌之參與 酒店及度假村累積簽賬(「合資格簽賬」)滿HK\$1,500或以上(「簽賬要求」),可獲HK\$400簽 賬回贈1次,回贈次數上限為3次(「登記卡優惠」)。
