



## Welcome Offer Terms and Conditions:

1. The Welcome Offer (as defined in clause 2 of the Terms and Conditions) is only applicable to Cardmembers of Blue Cash® Credit Card from American Express issued by American Express International, Inc. ("American Express") in Hong Kong ("Cardmembers").
2. The Welcome Offer of HK\$200 cash back for successfully applying for Blue Cash® Credit Card from American Express Supplementary Card and have at least 1 successful transaction with this new Blue Cash Credit Card from American Express Supplementary Card in the first 2 months from the date of the new Supplementary Card approval ("Welcome Offer") is only valid for Supplementary Card application of Blue Cash Credit Card from American Express that is successfully received and approved by American Express between January 5, 2023 and March 31, 2023 (both dates inclusive) ("Promotion Period").
