



American Express Autopay Service Statement Credit Offer Terms and Conditions:

1. The promotion period of this program is valid from April 19 to July 19, 2021, both dates inclusive (**"Promotion Period"**).
2. This program is only applicable to the Cardmembers who receive this promotional email and hold an American Express® Credit Card issued by American Express International, Inc. (**"American Express"**) in Hong Kong and specified in this promotional email (**"Eligible Card"**) (**"Selected Cardmembers"**).
3. During the Promotion Period, Selected Cardmembers can enjoy the following offers for making monthly bill payment at Selected Merchants of Selected Categories (as defined in Clause 4 of the Terms and Conditions) via autopay or recurring billing arrangement with the Eligible Card ("Eligible Transaction") ("Offers"):

Category I: Telecom – receive HK\$50 Statement Credit upon making one bill payment of HK\$100 or above at the Selected Merchants via autopay

Category II: Entertainment – receive HK\$25 Statement Credit upon making one bill payment of HK\$50 or above for the Selected Services via autopay
4. Selected Merchants under Category I include 1010, 3HK, China Mobile Hong Kong, csl, HKT, HGC Broadband and SmarTone. Selected Services under Category II include Apple Music, Apple TV+, iCloud, Netflix and Spotify.
5. Only transactions conducted in Hong Kong Dollars will be eligible for the Offers.
6. Any Eligible Transaction posted before or after the Promotion Period is not qualified for the Offers.
7. Offers are only applicable once per Eligible Card account in each Category during the Promotion Period. For the avoidance of doubt, each Basic Card account and any related Supplementary Card account(s) will be treated as one Eligible Card account when calculating Eligible Transaction and Offers.
8. Please contact the Selected Merchants directly for autopay service enrollment or recurring billing arrangement.
9. Successful autopay service enrollment or recurring billing arrangement is subject to approval from respective merchants. The processing time of autopay enrollment, in general, takes 6 to 8 weeks and it varies from merchant to merchant. Please contact the respective merchants for details.
10. Eligible Transaction which is subsequently cancelled, refunded or disputed will be disqualified for the purpose of this program. The Offers will be clawed back from the concerned Eligible Card account without prior notice if the Offers are awarded.
11. The Offers will be credited to the Basic Card account of such Eligible Card in the month or the following month after the Eligible Transaction is posted ("Redemption Period"). To enjoy the Offers, the Eligible Card account must be valid and in good standing throughout the Promotion Period and Redemption Period. Otherwise, American Express reserves the right to cancel the Offers without any prior notice.
12. The Offers are non-transferable and cannot be exchanged for cash, gifts, other products or services.
