



Terms and Conditions:

1. Excludes any transactions for the Octopus – China T-Union Card.
2. A one-time registration is required for the Eligible Card which will be automatically registered for the following calendar month from the registration date and do not need to re-register.
3. The Registered Card Offer resets on the 1st day of each calendar month during the Promotion Period. Cardmembers must meet the Spending Requirement of HK\$300 prior to the end of a calendar month to be eligible for the HK\$30 statement credit within that calendar month.
4. Prior to payment, Cardmembers must first get Octopus on iPhone or Apple Watch and load the Registered Card to Apple Wallet on a compatible device. For more information, [click here](#).
5. The registration period commences on 2025/04/01 and ends on 2025/06/30, both dates inclusive (“Promotion Period”). Participation is limited to the first 10,000 Eligible Cards that are successfully registered.

Cardmembers must successfully register an Eligible Card during the Promotion Period (“Registered Card”), then spend a net amount of HK\$300 or more, in one transaction per calendar month (“Spending Requirement”) on [Octopus top up via Apple Pay](#) in Hong Kong (“Participating Merchants”) with the Registered Card during Promotion Period (“Eligible Transaction”) to receive HK\$30 back in statement credit per calendar month (“Registered Card Offer”).
7. The Registered Card Offer is open to selected individuals who hold selected Basic American Express® Cards issued by American Express International, Inc. (“American Express”) in Hong Kong (“Eligible Cards”), excluding American Express® Corporate Cards and Cards bearing the American Express name, brand or logo issued by partners of American Express.
