



Terms and Conditions:

1. To be eligible for the Registered Card Offer, Cardmembers are required to spend 5 times of HK\$100 or more in a single transaction with the Registered Card.
2. Only transactions in Hong Kong Dollars are eligible for the Registered Card Offer.
3. The registration period commences on 2024/05/09 and ends on 2024/06/30, both dates inclusive ("Promotion Period").
4. Cardmembers must successfully register an Eligible Card during the Promotion Period ("Registered Card"), then spend a net amount of HK\$100 or more, 5 times ("Spending Requirement") in-person, online or in-app at any American Express Card accepting merchants ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$50 back in statement credit ("Registered Card Offer").
5. Transactions must be charged to the Cardmember's Registered Card during the Promotion Period to be considered Eligible Transactions. If a Participating Merchant does not charge the Registered Card by 2024/06/30, the transaction may not be considered an Eligible Transaction.
6. The Registered Card Offer is open to selected Cardmembers who hold selected Basic American Express Cards issued by American Express International, Inc. ("American Express") in Hong Kong ("Eligible Cards"), excluding American Express® Corporate Cards and Cards bearing the American Express name, brand or logo issued by partners of American Express.
