



## Terms and Conditions:

1. The Registered Card Offer is only available online or in-app at selected streaming services in Hong Kong: [Disney+, Netflix, Netvigator/Now TV or Now E](#).
2. For any trial periods, Cardmembers must ensure they finish the trial period within sufficient time for the Registered Card to be charged by 2024/11/30.
3. Only transactions in Hong Kong Dollars are eligible for the Registered Card Offer.
4. The registration period commences on 2024/08/20 and ends on 2024/11/30, both dates inclusive ("Promotion Period"). Participation is limited to the first 30,000 Eligible Cards that are successfully registered.
