



Terms and Conditions:

1. A one-time registration is required for the Eligible Card which will be automatically registered for the following calendar month from the registration date and do not need to re-register.
2. The Registered Card Offer resets on the 1st day of each calendar month during the Promotion Period. Cardmembers must meet the Spending Requirement of HK\$50,000 prior to the end of a calendar month to be eligible for the HK\$2,500 statement credit within that calendar month.
3. The registration period commences on 2024/10/08 and ends on 2024/11/30, both dates inclusive ("Promotion Period").
4.
