



Terms and Conditions:

1. The registration period commences on March 18, 2025 and ends on May 5, 2025, both dates inclusive (“Promotion Period”).
2. This offer is only applicable to selected Cardmembers who hold selected Basic American Express® Cards issued by American Express International, Inc. (“American Express”) in Hong Kong (“Eligible Cards”), excluding American Express® Corporate Cards and Cards bearing the American Express name, brand or logo issued by partners of American Express. Other Cards held by the Selected Cardmember may not be Eligible Cards.
