



Terms and Conditions:

1. Only transactions in Renminbi (RMB) are eligible for the Registered Card Offer.
2. Prior to payment via Weixin Pay (Chinese mainland wallet) | 微信支付 (中國內地錢包), Cardmembers must load the Registered Card using a compatible device.
3. Excludes payment made via WeChat Pay HK.
4. The registration period commences on 2024/06/20 and ends on 2024/08/31, both dates inclusive ("Promotion Period").
5. Cardmembers must successfully register an Eligible Card during the Promotion Period ("Registered Card"), then spend a cumulative net amount of every HK\$500 in RMB equivalent ("Spending Requirement") in-person, online or in-app via Weixin Pay (Chinese mainland wallet) | 微信支付 (中國內地錢包) ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$50 back in statement credit ("Registered Card Offer").
6. Transactions must be charged to the Cardmember's Registered Card during the Promotion Period to be considered Eligible Transactions. If a Participating Merchant does not charge the Registered Card by 2024/08/31, the transaction may not be considered an Eligible Transaction.
7. The Registered Card Offer is open to individuals who hold selected Basic American Express® Cards issued by American Express International, Inc.
