



American Express Explorer™ Credit Card

Welcome Offers Terms and Conditions:

1. The Welcome Offers (as mentioned in clauses 3 to 6 of the Terms and Conditions) are only valid for approved American Express Explorer Credit Card applications that are submitted online via americanexpress.com.hk and such online application has been successfully approved by American Express International, Inc. (“American Express”) on or before September 30, 2021.
2. The specified offer cannot be changed after online application is submitted.
3. Online bonus: For Basic Cardmembers who submit their Card application online and all required valid documents within 7 working days from the date of application submission, city’super cash vouchers with a total value of HK\$100 will be sent to qualifying Basic Cardmembers within 12 weeks upon Card approval. 11. The first year annual fee waiver is applicable within 12 months from the date of approval of the Basic Card. Thereafter, annual Card fee of **HK\$1,800** of the following year (include one Basic Card and two Supplementary Cards) will be charged except that such fees may be waived by American Express if the Cardmember's annual spending on the Card is HK\$150,000 or above.
