



Terms and Conditions:

1. Foreign currency means any currency other than Hong Kong Dollars. If a transaction is converted to Hong Kong Dollars before being submitted to American Express (for example, if the merchant converts the transaction to Hong Kong Dollars at the point of sale), it will not be eligible for the offer.
2. A Currency Conversion Fee applies when payment is charged in a currency other than Hong Kong Dollars and this charge does not count toward the Spending Requirement. For more information regarding charges made in foreign currencies, please refer to the relevant [Cardmember Agreement](#).
3. The registration period commences on 2025/02/18 and ends on 2025/05/05, both dates inclusive ("Promotion Period").
4. Cardmembers must successfully register an Eligible Card during the Promotion Period ("Registered Card"), then spend a cumulative net amount of every HK\$52,000 in foreign currencies ("Spending Requirement") in-person, online or in-app at any American Express Card accepting merchants ("Participating Merchants") with the Registered Card during Promotion Period ("Eligible Transaction") to receive HK\$1,820 back in statement credit ("Registered Card Offer").
5. Transactions must be charged to the Cardmember's Registered Card during the Promotion Period to be considered Eligible Transactions. If a Participating Merchant does not charge the Registered Card by 2025/05/05, the transaction may not be considered an Eligible Transaction.
6. The Registered Card Offer is open to selected individuals who hold selected Basic The Platinum Card® issued by American Express International, Inc.
