3. Asia Miles is managed and operated by Asia Miles Limited (AML) and participation in Asia Miles is subject to the Asia Miles terms and conditions set out at www.asiamiles.com. You must be an Asia Miles member to earn Asia Miles and redeem Asia Miles awards. If you do not provide your Asia Miles account number, your Corporate Miles will not be auto-swept to Asia Miles account and you will not accrue Corporate Miles. Corporate Miles will be auto-swept to your Asia Miles account within 6-8 weeks - please refer to your monthly Card statement for a summary of Corporate Miles earned and transferred. For all Asia Miles balance enquiries or to redeem Asia Miles, please visit www.asiamiles.com and redeem.asiamiles.com for details.
4. For every HK\$15 eligible business spending on the American Express® Classic Corporate Card, you will earn 1 Corporate Mile which will be converted automatically to 1 Asia Mile.
