

## American Express® Cathay Pacific Elite Corporate Card Welcome Offers Terms and Conditions

The Company must provide a copy of the authorized email address to American Express. Asia Miles enrolment is automatic on approval of your American Express Cathay Pacific Corporate Card account. The Company will earn Asia Miles on all Cathay Pacific and infight transactions purchased on the American Express Cathay Pacific Corporate Card.
- 2. Card Members Rewards: An annual Card Member rewards program fee applies. Enrolment is not automatic and subject to Company approval.
