

Terms and Conditions

For Uber Rides

- “**Uber Ride**” refers to any vehicle or service type currently offered on the Uber mobile app in Indonesia, which may include UberMOTOR, UberPOOL, UberX, UberXL, UberBLACK.
- The discount only applies to the first two (2) Uber Rides completed by an Eligible Cardmember (as defined below) in Indonesia (“**Eligible Rides**”).
- The maximum discount amount is capped at IDR 40,000 per Eligible Ride (“**Maximum Discount Per Ride**”).

General

- The discount is available to holders of a basic or supplementary American Express Consumer Card issued in Indonesia by Bank Central Asia Tbk, PT Bank Danamon Indonesia, Tbk, Bank Negara Indonesia (persero) Tbk and holders of an American Express Corporate Card issued by PT Bank Danamon Indonesia, Tbk in Indonesia, each of whom have never previously completed an Uber Ride (as defined above) in any country (in the case of the discount on Uber Rides). The cards mentioned in the foregoing sentence shall be referred to as “**Eligible Cards**” and the holders of Eligible Cards shall be referred to as the “**Eligible Cardmembers**”.
- The discount is not available to holders of American Express Cards issued outside of Indonesia.
- The promotion period is from 12:00 a.m. on 27 November 2017 to 11:59 p.m. on 30 April 2018 (“**Promotion Period**”).
- The promotion code, once entered into the Uber mobile app, shall be valid for use from 12:00 a.m. on 27 November 2017 to 11:59 p.m. on 31 May 2018.
- The promotion code will only be valid on the Uber mobile app and Uber’s website at www.uber.com. Promotion codes may not be supported on older versions of Uber’s mobile apps.
- The promotion code will not be valid on any third party applications that may enable users to book Uber Rides in Indonesia.
- Unless otherwise stated, the discount for Uber Rides may not be used together with any other discount for Uber Rides that may be available in Indonesia.
- In the event that the fare of an Eligible Ride is less than the Maximum Discount Per Ride, there will be no refund or carrying over of the unused amount.
- In the event that the fare of an Eligible Ride is more than the Maximum Discount Per Ride, the Eligible Cardmember shall bear the additional amount and pay with the Eligible Card that is registered in the Uber App, as the case may be.
- The discount will be deemed fully redeemed once an Eligible Ride has been completed.
- In the event of cancellation of an Eligible Ride, cancellation fees and/or other applicable charges may apply. The Eligible Ride may be deemed completed and the discount may be applied against such fees and/or charges.
- For cancellation policies, please refer to the Help section in the Uber mobile app.
- The discount for Uber Rides available to an Eligible Cardmember shall not be transferable to another user, or be redeemable for cash.
- American Express and/or Uber reserve the rights to terminate this offer and/or replace the offer with another offer of similar value.

- Uber shall be solely responsible for the fulfilment of the offer and services offered by Uber to Eligible Cardmembers. American Express acts solely as a payment provider and is not responsible or liable in the event that any of the services or benefits are not provided or fulfilled by Uber.
