

Terms and Conditions

Spend Rs 1.20 Lacs in a Cardmembership year and get an Amazon voucher worth Rs 500.

Spend Rs 1.80 Lacs in a Cardmembership year and get an additional Amazon voucher worth Rs 500.

Spend Rs 2.40 Lacs in a Cardmembership year and get an additional Amazon voucher worth Rs 500.
