

Offer Terms and Conditions

- The “Offer” is open to only select American Express Cardmembers whose accounts are valid and in good standing. An American Express Cardmember for the purpose of this Offer means a person holding an American Express® Platinum Reserve SM Credit Card, American Express® Platinum Travel Credit Card, American Express® Gold Card, American Express Membership Rewards® Credit Card or American Express SmartEarn™ Credit Card issued by American Express Banking Corp. in India
- The Offer is not valid for American Express Cards except the Card mentioned above.
- The Offer is not valid for American Express Corporate Cards issued by American Express Banking Corp. in India or Cards issued by a third party bearing the name or trademark or service mark or logo of American Express ("Network Cards") issued in India.
- This Offer is valid from January 13, 2022 to March 31, 2022 (inclusive of both days), hereafter referred to as “Offer period”.
- The Offer is as below:
 - Cardmember to enrol the eligible Card for which the communication has been sent and make insurance transactions during the offer period on their enrolled American Express® Card (including the transactions on linked Supplementary Card(s)) and get 10 Membership Rewards® points for every Rs. 100 spent on Insurance transactions.
