### Comprehensive supplementary insurance during business trips<sup>3</sup>

- ▶ Business travel accident insurance: insured against the consequences of a travel accident, 24 hours a day, max. 30 days, max. cover: €500,000 on Air France and KLM flights and €350,000 on other flights.
- ▶ Business travel inconvenience insurance<sup>4</sup>: for emergency purchases in case of delayed flights or lost luggage, max. cover: €1,500 on Air France and KLM flights and €1,050 on other flights.
- ▶ Business travel baggage and personal possessions insurance: insured against the consequences of theft, loss or damage to luggage and personal effects, max. cover: €5,000 per trip.
- ▶ Business trip cancellation protection on Air France and KLM flights, max. cover: €4,500.
- ▶ Standard damage and theft coverage at car rental, max. reimbursement: €75,000.
