



Terms & Conditions for The American Express® Singapore Airlines KrisFlyer Credit Card Sign Up Promotion – Up to 14,000 KrisFlyer Miles for New to American Express Card Members

Promotion

1. The American Express Singapore Airlines KrisFlyer Credit Card Sign Up Promotion (the “Promotion”) is valid from 28 January 2026 to 31 March 2026, both dates inclusive (the “Promotion Period”).
2. To be eligible for this Promotion, you must satisfy all the following criteria:
 - 2.1 You do not hold an existing basic or supplementary consumer Card from American Express.
 - 2.2 You do not previously hold a basic or supplementary consumer Card from American Express that was terminated or otherwise cancelled in the last twelve (12) months prior to the application.
 - 2.3 You must apply for the Singapore Airlines KrisFlyer Credit Card with American Express within the Promotion Period and receive approval by 31 March 2026 (date inclusive).
 - 2.4 You must not have already submitted an application for a basic American Express Singapore Airlines KrisFlyer Credit Card under any other promotion(s).

Mechanics

3. If you fulfil the following Criteria, which includes spending S\$1,000 on eligible purchases of goods and services within the first two (2) months upon Card approval (“Qualifying Spend Period”), you will receive the Gift (as indicated in the table below):

Gift	Criteria
7,900 bonus KrisFlyer miles	Spend S\$1,000 within the Qualifying Spend Period (the “Qualifying Spend”)
In addition, you will earn KrisFlyer miles as follows*:	
5,000 KrisFlyer miles	Welcome Bonus for your first charge on Card (applicable for first-time Singapore Airlines Credit Card applicants only)
1,100 KrisFlyer miles	Awarded on the S\$1,000 of Qualifying Spend (based on 1.1 KrisFlyer miles per S\$1 spent in Singapore Dollars)
Up to a total of 14,000 KrisFlyer miles

4. Spend made by Supplementary Card Member(s) will count towards the S\$1,000 Qualifying Spend.
5. Upon meeting the Qualifying Spend, the Gift will be awarded to you within approximately twelve (12) weeks.
6. You agree that we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member’s Account and/or adjusting any KrisFlyer miles awarded to you, if:
 - (a) It has been found that you held a basic or supplementary consumer Card from American Express in the last twelve (12) months;
 - (b) the Qualifying Spend is not met because the relevant transactions are subsequently cancelled, reversed or refunded; and/or
 - (c) you did not meet any eligibility criteria for the Promotion.

In addition, if you cease to be a Card Member for any reason within six (6) months of Card approval for The American Express Singapore Airlines KrisFlyer Credit Card Account, we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member's Account and/or adjusting any KrisFlyer miles awarded to you.
8. The Qualifying Spend must be posted within the Qualifying Spend Period to count toward the Gift criteria.
9. For non-eligible spend, please visit go.amex.sg/exclusions for full list of non-eligible purchases or transactions, which is non-exhaustive and is subject to changes from time to time.
10. Your Card Member Account must be in good standing and not cancelled for any reason to qualify for the Gift.
11. No expedite requests will be allowed/entertained.
12. The Gift is strictly not transferrable or exchangeable for cash.
13. The Promotion shall not apply in conjunction with other promotional programs, offers, discount cards, vouchers, or VIP privileges, unless otherwise stated.
