



Terms & Conditions for The American Express® Platinum Credit Card Sign Up Promotion – 40,000 bonus Membership Rewards® points for New to American Express Card Members

Promotion

1. The American Express Platinum Credit Card Sign Up Promotion (the “Promotion”) is valid from 17 June 2026 to 31 January 2027, both dates inclusive (the “Promotion Period”).
2. To be eligible for this Promotion, you must satisfy all the following criteria:
 - 2.1 You do not hold an existing basic or supplementary consumer Card from American Express.
 - 2.2 You do not previously hold a basic or supplementary consumer Card from American Express that was terminated or otherwise cancelled in the last twenty-four (24) months prior to the application.
 - 2.3 You must apply for the Platinum Credit Card with American Express within the Promotion Period and receive approval within forty-five (45) days from the date of application.
 - 2.4 You must pay the full Annual Membership Fee of S\$327 (incl. of 9% GST) in the first monthly statement.
 - 2.5 You must not have already submitted an application for a basic American Express Platinum Credit Card under any other promotion(s).

Mechanics

3. If you fulfil the following criteria which includes spending S\$4,000 on eligible purchases of goods and services within the first three (3) months upon Card approval (“Qualifying Spend Period”), you will receive the Gift (as indicated in the table below):

Gift	Criteria
40,000 bonus Membership Rewards points	Spend S\$4,000 within the Qualifying Spend Period (the “Qualifying Spend”)
	Pay the full Annual Membership Fee of S\$327 (incl. of 9% GST) in the first monthly statement

4. Spend made by Supplementary Card Member(s) will count towards the S\$4,000 Qualifying Spend.
5. Upon meeting the Qualifying Spend and paying the full Annual Membership Fee of S\$327 (incl. of 9% GST), the Gift will be awarded to you within approximately twelve (12) weeks.
6. You agree that we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member’s Account and/or adjusting any Membership Rewards points awarded to you, if:
 - (a) It has been found that you held a basic or supplementary consumer Card from American Express in the last twenty-four (24) months;
 - (b) the Qualifying Spend is not met because the relevant transactions are subsequently cancelled, reversed or refunded;
 - (c) you did not meet any eligibility criteria for the Promotion; and/or
 - (d) the Annual Membership Fee paid for your first membership year is subsequently reversed for any reason.

In addition, if you cease to be a Card Member for any reason within six (6) months of Card approval for The American Express Platinum Credit Card, we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member's Account and/or adjusting any Membership Rewards points awarded to you.
8. The Qualifying Spend must be posted within the Qualifying Spend Period to count toward the Gift criteria.
9. For non-eligible spend, please visit go.amex.sg/exclusions for full list of non-eligible purchases or transactions, which is non-exhaustive and is subject to changes from time to time.
10. Your Card Member Account must be in good standing and not cancelled for any reason to qualify for the Gift.
11. No expedite requests will be allowed/entertained.
