

**Terms & Conditions for The Platinum Card® Sign Up Promotion –
Up to 200,000 Membership Rewards® points for New to American Express Card Members**

Promotion

1. The Platinum Card Sign Up Promotion (the "Promotion") is valid from 28 January 2026 to 31 March 2026, both dates inclusive (the "Promotion Period").
2. To be eligible for this Promotion, you must satisfy all the following criteria:
 - 2.1 You do not hold an existing basic or supplementary consumer Card from American Express.
 - 2.2 You do not previously hold a basic or supplementary consumer Card from American Express that was terminated or otherwise cancelled in the last twelve (12) months prior to the application.
 - 2.3 You must apply for The Platinum Card with American Express within the Promotion Period and receive approval 31 March 2026 (date inclusive).
 - 2.4 You must pay the full Annual Membership Fee of S\$1,744 (incl. of 9% GST) in the first monthly statement.
 - 2.5 You must not have already submitted an application for a Basic Platinum Card under any other promotion(s).

Mechanics

3. If you fulfil the following Criteria, which includes spending S\$8,000 on eligible purchases of goods and services within the first three (3) months upon Card approval ("Qualifying Spend Period for Gift A"), you will receive the Gift (as indicated in the table below):

4. In addition, if you fulfil the following Criteria, which includes making a min. spending of S\$1 on eligible purchases of goods and services during the fifteenth (15th) month of Card Membership ("Qualifying Spend Period for Gift B"), you will receive the Gift (as indicated in the table below):

5. Spend made by Supplementary Card Member(s) will count towards both the S\$8,000 Qualifying Spend for Gift A and the S\$1 Qualifying Spend for Gift B.
6. Upon meeting the Qualifying Spend for Gift A and paying the full Annual Membership Fee of S\$1,744 (incl. of 9% GST), Gift A will be awarded to you within approximately twelve (12) weeks.
7. Upon meeting the Qualifying Spend for Gift B, Gift B will be awarded to you within approximately twelve (12) weeks.
8. You agree that we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member's Account and/or adjusting any Membership Rewards points awarded to you, if:
 - (a) It has been found that you held a basic or supplementary consumer Card from American Express in the last twelve (12) months;
 - (b) the Qualifying Spend is not met because the relevant transactions are subsequently cancelled, reversed or refunded;
 - (c) you did not meet any eligibility criteria for the Promotion; and/or
 - (d) the Annual Membership Fee paid for your first membership year is subsequently reversed for any reason.

General

In addition, if you cease to be a Card Member for any reason within six (6) months of Card approval for The Platinum Card, we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member's Account and/or adjusting any Membership Rewards points awarded to you.
10. The Qualifying Spend for Gift A and Gift B must be posted within each respective Qualifying Spend Period to count toward the Gift criteria.

12. Your Card Member Account must be in good standing and not cancelled for any reason to qualify for the Gift(s).
13. No expedite requests will be allowed/entertained.
