

The American Express Singapore Airlines Business Credit Card & The Platinum® Bundle Offer Programme Terms and Conditions (the "Terms and Conditions")

- Participation in the American Express Singapore Airlines Business Credit Card & The Platinum® Card/ The American Express Platinum Credit Card Bundle Offer(s) Programme (the "**Programme**") is deemed acceptance of these Terms and Conditions.
- The Programme is offered by American Express International Inc., Singapore Branch, a Delaware corporation with a registered office at 1 Marina Boulevard, #22-00 One Marina Boulevard Singapore 018989 ("**Amex**").
- To participate in the Programme, an individual must meet the following criteria (collectively, the "**Eligibility Criteria**"):
 - must not have held The American Express Platinum Credit Card within the last [12] months; and The Platinum Card® within the last [24] months
 - apply for the American Express Singapore Airlines Business Credit Card **and** either one of the following cards issued by Amex in Singapore: (i) The Platinum Card or (ii) The American Express Platinum Credit Card, within the Promotional Period (as defined below); and

A Participant who does not submit his/her card applications through either Website Link, the Unique Links or the specific paper application form (as the case may be) shall not be eligible to receive the Bundle Offer.
