



**Terms & Conditions for The Platinum Card® Sign Up Promotion –
53,750 Membership Rewards® points for Existing American Express Card Members**

Promotion

1. The Platinum Card Sign Up Promotion (the “Promotion”) is valid from 27 November 2025 to 27 January 2026, both dates inclusive (the “Promotion Period”).
2. To be eligible for this Promotion, you must satisfy all the following criteria:
 - 2.1 You do not previously hold a basic Platinum Card from American Express that was terminated or otherwise cancelled in the last twelve (12) months prior to the application.
 - 2.2 You must apply for The Platinum Card with American Express within the Promotion Period and receive approval by 27 January 2026 (date inclusive).
 - 2.3 You must pay the full Annual Membership Fee of S\$1,744 (incl. of 9% GST) in the first monthly statement.

 - 2.5 You must not have already submitted an application for a Basic Platinum Card under any other promotion(s).

Mechanics

3. If you fulfil the following Criteria, which includes spending S\$3,000 on eligible purchases of goods and services within the first three (3) months upon Card approval (“Qualifying Spend Period”), you will receive the Gift (as indicated in the table below):

Gift	Criteria
50,000 bonus Membership Rewards points	Pay the full Annual Membership Fee of S\$1,744 (incl. of 9% GST) in the first monthly statement
	Spend S\$3,000 within the Qualifying Spend Period (the “Qualifying Spend”)
In addition, you will earn Membership Rewards points as follows:	
3,750 Membership Rewards points	Awarded on the S\$3,000 of Qualifying Spend (based on 2 Membership Rewards points for every S\$1.60 spent in Singapore Dollars)
Total of 53,750 Membership Rewards points	

4. Spend made by Supplementary Card Member(s) will count towards the S\$3,000 Qualifying Spend.
5. Upon meeting the Qualifying Spend and paying the full Annual Membership Fee of S\$1,744 (incl. of 9% GST), the Gift will be awarded to you within approximately twelve (12) weeks.
6. You agree that we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member’s Account and/or adjusting any Membership Rewards points awarded to you, if:
 - (a) the Qualifying Spend is not met because the relevant transactions are subsequently cancelled, reversed or refunded;



- (b) you did not meet any eligibility criteria for the Promotion; and/or
- (c) the Annual Membership Fee paid for your first membership year is subsequently reversed for any reason.

General

In addition, if you cease to be a Card Member for any reason within six (6) months of Card approval for The Platinum Card, we may take such steps as necessary to recover the value of the Gift(s) from you, including charging an equivalent amount to your Card Member's Account and/or adjusting any Membership Rewards points awarded to you.
8. The Qualifying Spend must be posted within the Qualifying Spend Period to count toward the Gift criteria.
9. For non-eligible spend, please visit go.amex.sg/exclusions for full list of non-eligible purchases or transactions, which is non-exhaustive and is subject to changes from time to time.
10. Your Card Member Account must be in good standing and not cancelled for any reason to qualify for the Gift(s).
11. No expedite requests will be allowed/entertained.
