

Definitions

Capitalized terms set out below shall have the following meanings as and when used in this document:

- "American Express" means American Express (Thai) Co., Ltd.
- "Card" means American Express Platinum Card issued by American Express in Thailand only.
- "Eligible Cardmember" means a basic American Express Platinum Cardmember, holding the Card issued by American Express.
- "Eligible Transaction" means cumulative transactions totaling Baht 3,000 made by an Eligible Cardmember, or by any supplementary cardmember(s) under the Eligible Cardmember's account, using the valid Card, in a calendar month during the Promotion Period, at Grab in Thailand only.
- "EXTRA Points" means the extra American Express Membership Rewards points in addition to the Membership Rewards base points that the Eligible Cardmembers will earn from the Eligible Transaction(s) under this Promotion.
- "Promotion" as defined in item (iii) of the Terms and Conditions below.
- "Promotion Period" means the period from August 1, 2022 to December 31, 2022 (both dates inclusive).

Terms and Conditions

- (i) The Promotion and the EXTRA Points referred to in this communication are only applicable to the Eligible Cardmembers.
- (ii) The spending made by a supplementary cardmember under the Eligible Cardmember's account during the Promotion Period shall be included in the calculation of an Eligible Transaction.
- (iii) An Eligible Cardmember can earn five (5) Membership Rewards points (comprising of four (4) EXTRA Points and one (1) regular base point) for every Baht 25 spent when an Eligible Cardmember makes a successful Eligible Transaction, capped at a maximum of 1,200 EXTRA Points per Card account per calendar month ("**Promotion**").
- (iv) This Promotion is only available at Grab in Thailand only.
- (v) American Express will credit the EXTRA Points to the Eligible Cardmembers' accounts latest by **March 31, 2023** (or any other dates as American Express may otherwise notify the Eligible Cardmembers in advance).
- (vi) Any transaction that has been cancelled or refunded are invalid and will not be eligible for this Promotion, regardless of whether such transaction fits the requirements of an Eligible Transaction.
- (vii) American Express reserves the right to solely offer this Promotion to the Eligible Cardmembers, whose accounts are active, in good standing and not in breach of any Terms and Conditions of the American Express Card membership during the Promotion Period up until the day the EXTRA Points are credited to their Card accounts.
- (viii) The Promotion is non-transferable and cannot be exchanged for cash. American Express reserves the right to substitute the offers under this Promotion with any other offers or items of similar value and to amend any Terms and Conditions of this Promotion (including but not limited to terminating and suspending the Promotion) at any time in compliance with applicable laws and regulations.
- (ix) The Terms and Conditions of the Card and the American Express Membership Rewards program shall apply.
