

Definitions

Capitalized terms set out below shall have the following meanings as and when used in this document:

“**American Express**” means American Express (Thai) Co., Ltd.

“**Card**” means American Express Gold Card issued by American Express in Thailand only.

“**Eligible Card member**” means a basic cardmember who holds an American Express Gold Card during the Promotion Period.

“**Eligible Transaction**” means a cumulative transaction of Baht 3,000 made by the Eligible Card member, or by any supplementary Card member(s) under the Eligible Card members’ account, in a calendar month during the Promotion Period, at Grab in Thailand only.

“**EXTRA Points**” means the extra membership rewards points in addition to the membership rewards base points that the Eligible Card members will earn from the Eligible Transaction(s) under this Promotion.

“**Promotion**” means EXTRA membership rewards points awarded to Eligible Card member for Eligible Transaction.
