Terms and Conditions for the Extra THAI American Express Platinum points for THAI American Express Platinum

Definitions

Capitalized terms set out below shall have the following meanings as and when used in this document:

- "American Express" means American Express (Thai) Co., Ltd.
- "Card" means THAI American Express Platinum Credit Card.
- "Eligible Card member" means a Basic THAI American Express Platinum Credit Card member, holding the Card issued by American Express.
- "Eligible Transaction" means a transaction of Baht 100,000 and above made by the Eligible Card member or any Supplementary Card member(s) under the Eligible Card member's account during promotion period.
