Automation

- Automate and customize how you receive and process financial transaction and settlement information
- Replace manual processes in your reconciliation process



Secure Retrieval

- Data files are retrieved via Secure File Transfer Protocol (SFTP) using Secure Socket Layer (SSL)
- Files are securely transferred across an encrypted channel in compliance with American Express security policies and industry standards



File Frequency

- Files are provided daily
- Files are created and sent when settlements are ready
- You can request empty files to be sent as scheduled, even when no transactions have occurred



Data Retention

- Files up to 60 days old from the present date can be recreated on request
- An ad hoc file can provide up to 18 months of your most recent transaction history



File Formats

- Files available in Fixed and Delimited (CSV or TAB) formats



File Structure

- Raw Data Global Reconciliation file is constructed from records with data fields
- Three levels of data options are available: Submission (Batch), Transaction (Charge), and Transaction Pricing



Referencing Data

- File contains transactional referencing to help reconcile financials more easily
- Transactional referencing includes: Invoice Reference Number (30 bytes), Transaction ID, Approval Code
- Industry referencing includes: Travel Ticket Number, Policy Number, Rental Agreement Number



Card Masking (Optional)

- Display the first 6 digits and the last 4 digits of a 15-digit Card Member number to protect data and minimize exposure
- Mask middle 5 digits of the Card Member number with XXXs, e.g. 123456XXXXX1234



Consolidated Files

- Consolidate financial data from multiple countries in the same region into a single file, e.g. consolidate UK, France, Germany and/or other European countries into single EMEA file
- Different regions require separate files i.e. EMEA, JAPA, LAC, North America



Transition to The Raw Data Global Reconciliation File

- Both the Global and older file formats can be transmitted at once to support transition
- We offer various supporting documentation to assist with migration

Raw Data File Set Up

- Contact your American Express representative to get set up
- Allow 6-8 weeks to integrate Raw Data into your accounting system, depending on your IT department
